Steampunk Farms Rescue Barn provides lifelong sanctuary to abused, neglected, and abandoned farmed and ambassador animals, prioritizing those most at risk and least likely to be adopted. As a safety-net sanctuary, we focus on the holistic rehabilitation of animals with complex needs, offering species-appropriate enrichment, companionship, and care tailored to each animal's history and condition. Animals enjoy a natural mountain environment with fresh produce from small farms, seasonal treats, hay, grain, and opportunities to engage in instinctive behaviors. Our rescue and sanctuary work forms the foundation for broader educational and advocacy efforts that promote compassion, sustainability, and animal welfare.

Part and Line Number: **Part III - Line 28**

Steampunk Farms Rescue Barn provided daily care and feeding for approximately 450 resident sanctuary animals, including pigs, goats, sheep, donkeys, chickens, ducks, dogs, and feral cats. Each species receives tailored nutrition our pigs enjoy a custom grain blend enriched with fermented barley for longevity, while poultry, canines, and felines receive high-quality, species-appropriate diets. A new hay provider delivers and stacks over 50 days of hay per trip, reducing labor and improving efficiency. Local farms donate seasonal produce and offer discounts on nutritious but unsellable fruits and vegetables, reducing waste while enriching diets. Open-land grazing, shelters from sun and storm, laundering, heat pads, transport, and fans all support our core mission of care and enrichment. Daily routines include multiple feedings, clean water, and activities suited to each animal's instincts. These quiet, repeated acts of care form the living heartbeat of sanctuary life.

Part and Line Number: **Part III - Line 29**

Veterinary care and special needs supplies accounted for the second largest share of donor-supported expenses. As a safety-net sanctuary, Steampunk Farms Rescue Barn accepts animals with urgent, chronic, or often critical medical needs. Many arrive with untreated injuries, advanced illness, or congenital conditions. Neuters remain our highest veterinary cost and our greatest preventive value, helping stem future suffering. Other care included diagnostics, wound management, pain control, and disease treatment. Special needs funding supported the long-term care of paralyzed, mobility-impaired, and deformed residents—many of whom require adaptive gear, custom bedding, supplements, and daily medication. With each new arrival, we reevaluate care priorities, allocating resources with compassion and precision to provide comfort, dignity, and quality of life for those who've known too little of either.

In response to economic shifts and reduced visibility on traditional fundraising platforms, Steampunk Farms Rescue Barn restructured its outreach to focus on storytelling as a primary mode of donor engagement. We published narrative-rich content highlighting cruelty-free environmental stewardship and farmed animal advocacy, deepening emotional connection with our supporters. This authentic, educational approach helped us reach new audiences and build lasting relationships. In tandem, we expanded our cruelty-free fundraising line, offering handmade soaps and body products, with 100% of proceeds supporting sanctuary operations. These offerings are more than merchandise—they're mission in a bottle, connecting our values to everyday use. Together, these efforts brought in a new tier of recurring supporters whose purchases and donations help stabilize income while advancing public understanding of compassionate living.
